



## Michigan Alliance for Legal Reform launches to restore fairness, curb lawsuit abuse

Broad coalition of Michigan business leaders call for common-sense legal reform

**Lansing, MICH** (Nov. 12, 2025) - Leading Michigan business and policy organizations today launched the **Michigan Alliance for Legal Reform**, a new, broad-based coalition dedicated to reining in lawsuit abuse and restoring balance and fairness in Michigan's legal system.

The Alliance's members represent over 30 – and growing – influential statewide associations and employers, including the **Michigan Chamber of Commerce, Michigan Farm Bureau, Michigan Manufacturers Association, Michigan Realtors, Michigan Retailers, and the Small Business Association of Michigan**. Together, they're pushing for legislative solutions that align Michigan with national best practices and strengthen economic competitiveness. (Full list below).

### Why It Matters | The Costs

Michigan's legal system is costly for everyone, even when they don't step foot into a courtroom. Today, the average Michigan household pays over [\\$3,000 annually](#) on a trickle-down "tort tax," and our legal climate costs us nearly [100,000 job opportunities](#) every single year.

"Lawsuit abuse is on the rise in Michigan. Slowly but surely, our legal system is turning into one that prioritizes dollars over justice, and Michigan job providers, families and communities are footing the bill," said **Zach Rudat, director of the Michigan Alliance for Legal Reform**. "Michigan needs durable, practical reforms that restore balance, protect taxpayers and make our legal system work for everyone again."

### National Hotspot, Statewide Consequences

Michigan is increasingly viewed as a national hotspot for lawsuit abuse, with ripple effects that drive up costs for everyone. While other states have taken legislative steps to modernize their civil justice systems and curb lawsuit abuse, Michigan has yet to act, leaving its economy and reputation at a disadvantage in the national marketplace.

"Expansive rulings from Michigan's Supreme Court combined with legislators' liability-expanding agenda have allowed lawsuit abuse to drive up costs and drive out jobs," said **Tiger Joyce, president of the American Tort Reform Association**. "If legislators can pursue commonsense reforms instead of bills that over-regulate and hamper entrepreneurship, Michigan can lower costs and grow its economy."

### Reform Priorities

The Alliance is calling on lawmakers to act on two immediate priorities:

1. **Restoring Michigan's "Open and Obvious" premise liability protection**, bringing the state in line with 41 others across the nation and reestablishing fairness for property owners.

2. **Implementing transparency measures for Third Party Litigation Funding (TPLF)**, a judicial financing practice where outside investors fund lawsuits with no state oversight, disclosure or guardrails.

“Without transparency and proper oversight, third party litigation funding can turn our justice system into a Black Market version of Wall Street. These commonsense measures will ensure integrity, protecting taxpayers from predatory practices, job providers from excessive lawsuits and our state and country from national security threats,” said **Rep. Mike Harris**, sponsor of new TPLF transparency reforms being introduced today – **House Bill 5281**.

### Shared Call for Action

Leaders from across the state’s business community – representing employers small and large, from manufacturing and agriculture and homebuilding to retail and real estate – say legal reform is essential to ensure fairness, support growth and create a more stable, predictable environment for employers and workers alike.

“Lawsuit abuse is one of the biggest risks facing Michigan job providers. It drives up the cost of doing business, stifles investment, and limits economic growth and opportunity for both employees and employers. If we want a stronger, prosperous Michigan for all, legal reform must be a top priority in Lansing.”
